Dear Cincinnati Property Owner:

The Urban Forestry Assessment that provides funding to plant and care for the wonderful street trees throughout our city has been renewed. On February 20, 2025, Cincinnati City Council passed Resolution No. 7-2025 declaring the necessity to levy a special assessment for the planting, care, maintenance, trimming, and removal of public trees in and along the streets and the public right-of-way within the City of Cincinnati's Urban Forestry Maintenance District for fiscal year 2027. This assessment shall be levied by the front foot method at a rate of \$0.31 per front foot of each real estate parcel abutting the right-of-way, providing the City with funding necessary to conduct 24-7 emergency response for downed trees in the right of way, a six-year preventative maintenance cycle, routine stump grinding, replacement of all trees removed, and systematic planting to improve tree canopy in the highest areas of need throughout the city.

Our records indicate that you are the owner of Hamilton County Auditor parcel number(s) (2040018001300) and that the assessment for said parcel(s) is equal to or greater than \$500.00. To access a copy of Resolution 7-2025, the Urban Forestry Program's fiscal year 2027 work plan, and the proposed budget, please visit the Cincinnati Park Board website or in person at the office of the Clerk of Council, Room 308, City Hall, 801 Plum Street, Cincinnati, Ohio between the hours of 8:00 AM and 5:00 PM, Monday through Friday.

The assessment will be included with your December 2025 tax bill, which will be sent to you by the Hamilton County Treasurer, payable to them with your property taxes. Please note, the City Treasurer will not accept payment of the estimated assessment or the actual assessment. If you wish to object to the proposed assessment, please deliver a written response within 14 days of the date that you receive this letter to:
